The "Anti Corruption Poster and Video Competition" being held by Russia among BRICS countries.

The contest will be held in two stages: Semi Final and Final. At Semi Final stage, each of the BRICs member countries will submit online; one best poster and one best video to Russia by 31.10.2019 for onward transmission to the International jury for selection of final winners. Besides 10 best posters and 10 best videos will also be submitted by every BRICS country to be hosted on the official website for exhibition. Each contestant will have to register on the website. Prizes will also be distributed for the purpose. A National Committee; to be constituted for the purpose; will evaluate the works."

The Competition's rules are available at the link <http://anticorruption.life/en>. It will be held for two categories - "The Best Poster" and "The Best Video". The contest will be open to all nationals and BRICS countries (individuals, creative terms and legal entities included) between the age of 14 to 35 years.
